

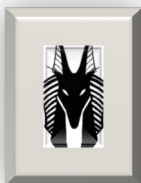
## **ANUBIS PARANORMAL RESEARCH ORGANIZATION**



### **Researcher**

Plans, organizes, and conducts research concerning client location in areas of scientific, cultural, and historical significance for use in paranormal investigations. Research will involve documentation of physical attributes of location and significant events or deaths that have occurred at the client location. Conducts research on client locations and provides parallel perspective between research and collected evidence. Prepares reports of research material for presentation to client and for use by the team. Conducts investigations of paranormal phenomenon using scientific methodology with a focus to debunk strange occurrences. Conducts investigation of client locations using EMF meters, audio/video recording devices, digital cameras and other applicable equipment. Examines evidence obtained during the investigation for identification and analysis. Reports findings of evidence from investigations to Tech Manager and/or management team. Performs any duties necessary as assigned by management.

1. Conducts Research on client location specifically reporting detail about location topography, history and focusing on any significant events or deaths that have occurred.
2. Provides reports of finding to be presented to the client and management team.
3. Provides initial analysis with quick location info to Case Manager and Lead Investigator for logistical purposes.
4. Investigates client location and attempts to debunk client's claims or document paranormal activity.
5. Assists in setup/breakdown of equipment at client location under the direction of Lead Investigator / Tech Manager or above.
6. Reviews evidence recorded with personal equipment and submits findings. Will be required and assigned to assist Tech Manager with review of evidence with group equipment. Will be responsible for meeting assigned deadlines set by Tech Manager for evidence review.

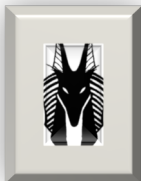
7. Follows the direction of Director / General Manager and assists in duties as assigned.
